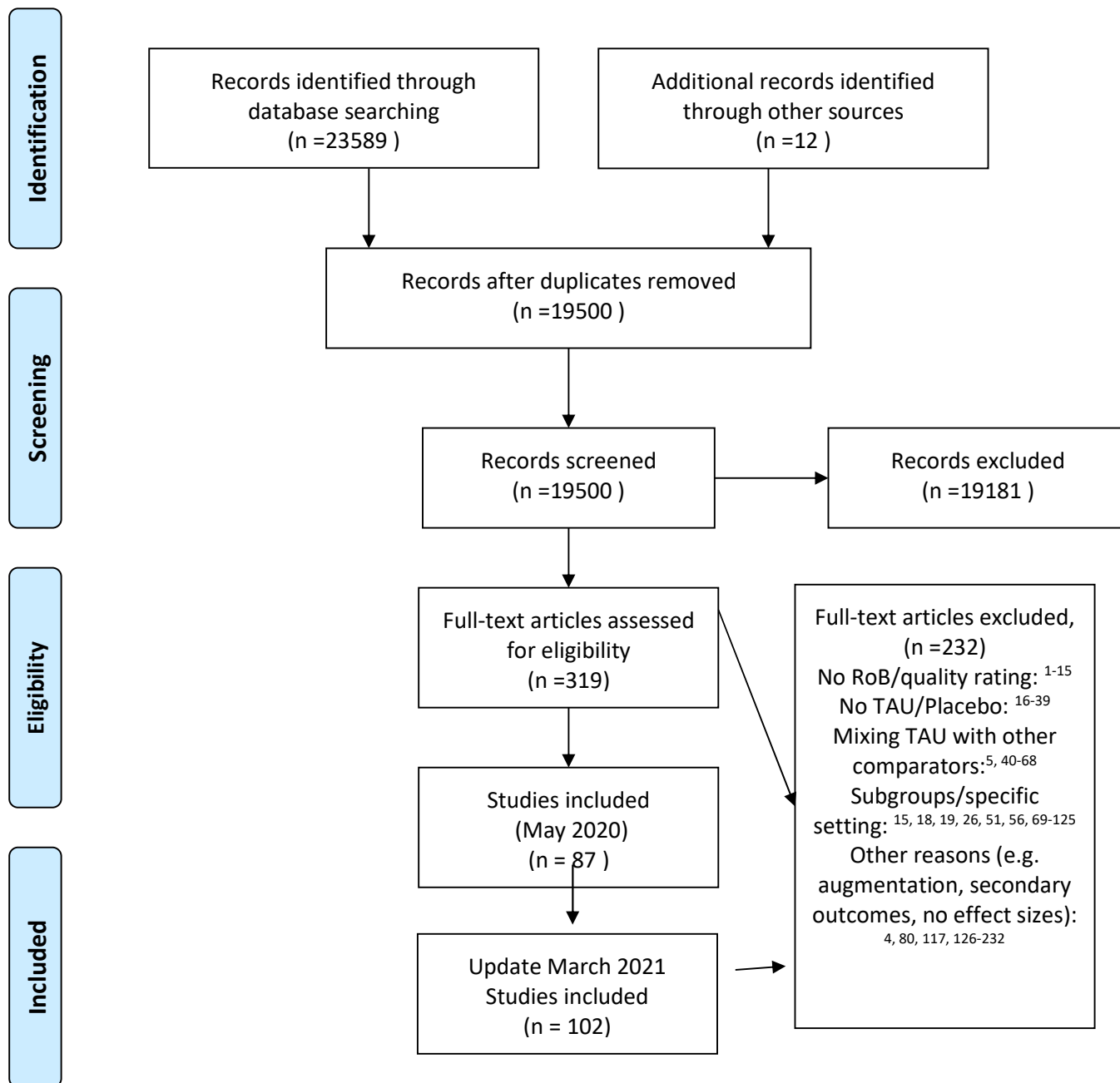


Supplement: Figure 1: PRISMA Flow Diagram with references
