### **Disclaimer of Liability**

With the conclusion of the contract, the contracting party undertakes to comply with the hygiene measures put in place by the organizer before, during and after the event to protect against infection with the Covid-19 virus. Failure to comply with the regulations can result in (partial) exclusion from the event; in this case, there is no (partial) claim to reimbursement of the contractually agreed remuneration. If the DBG is prevented from holding the event due to force majeure, it will be released from any obligations. The cancellation of the event due to official orders to contain the Covid-19 pandemic is also considered force majeure. In addition, the DBG reserves the right to hold the event online at short notice - due to the infection situation in connection with the Covid-19 pandemic - immediately before the date of the face-to-face event - to protect the participants, even if there is no official order for this. With the conclusion of the contract, the contracting party accepts to pay the contract fee in this case as well. The DBG, in turn, ensures that the contracting party can present itself in the virtual space with the same intention as would have been the case at a face-to-face event.

The following exclusion of liability is deemed to have been agreed:

- 1. The organizer assumes no liability for damage of any kind, in particular not for damage to the exhibition stand (stand design, equipment, exhibits) and the property of the people working there or for damage suffered by third parties as a result of the exhibition stand, unless such damage can be proven were caused intentionally or through gross negligence by the organizer or its employees.
- 2. The liability of the organizer for consequential damage is excluded.
- 3. The exhibitor releases the organizer from all claims that are made against the organizer due to incidents and damages in the sphere of influence of the exhibitor.
- 4. The exhibitor is responsible for all personal accidents and damage that arise in connection with the assembly or demonstration of the exhibition equipment
- 5. If the DBG has to cancel the event at short notice for reasons for which it is responsible, it is obligated to partially or fully refund the financial benefits received from the exhibitor. The DBG is entitled to withhold part of the amount already received from the exhibitor if the exhibitor's logo was used in the run-up to the event to indicate the exhibitor's support. However, the reimbursement always includes at least 50% of the total amount.
- 6. If the contract is withdrawn, the full invoice amount will be charged if the exhibition space cannot be reassigned.
