PREAMBLE:

That on September 28, 2018, the Parties have celebrated a Specific Collaboration Agreement to carry on an Undergraduate Student Exchange Program (Exchange Program), to enable a student registered in one University (Home University) to follow courses in the other (Host University) in order to satisfy part of the credits requirements necessary to qualify for a degree at the Home University, hereinafter referred to as “**THE SPECIFIC AGREEMENT**”.

That in Article number 4. of “**THE SPECIFIC AGREEMENT**”, it was established that its duration would last until April 2nd, 2023, beginning with its signing, and it may be extended, by means of the corresponding Extension Agreement, following an evaluation of its results.

On one hand, Dr. Leonardo Lomelí Vanegas and Dr. Patricia Dolores Dávila Aranda, with the attributes that proceed from their positions as Secretary General and Secretary for Institutional Development of the **Universidad Nacional Autónoma de México**, respectively, have the authority to sign the present Agreement, on behalf and legal representation of it, in accordance with the Regulation that delegates and distributes authority to subscribe agreements, contracts and other instruments signed by the UNAM, published in Gaceta UNAM on September 5th 2011; assisted by Dr. Francisco José Trigo Tavera, Coordinator for International Affairs, as well as by MA Gerardo Reza Calderón, Director General for Cooperation and Internationalization.

And on the other, Prof. Dr. Joybrato Mukherjee, President of the University of **Justus Liebig Universität Gießen**, on behalf and legal representation of it, according to The Higher Education Act “Hochschulgesetz” (§ 44 Section 1, clause 1, HessHG).

DECLARE:

That both Parties mutually recognize their legal status and that of their representatives.

That it is their will to celebrate the present Extension Agreement with the purpose of furthering the promotion of the Exchange Program that operates between both Universities.

AGREE:

The Parties agree to extend the validity of “**THE SPECIFIC AGREEMENT**” for 5 (five) additional years, beginning with the signing of the present Agreement.

IN WITNESS WHEREOF the duly authorized officers of the Parties have executed and delivered this Agreement in duplicate, in Spanish and in English, both versions being equally valid, on **April 2nd, 2023**.
