#### **Preamble**

Justus Liebig University Giessen is a lawful corporation under public law and at the same time a <u>state institution</u>, which was founded in 1607 and is dedicated to research and education. According to the "Hochschulgesetz" (§ 44 Section 1, clause 1, <u>HessHG</u>) its representative is the president. Its seat is Ludwigstrasse 23, 35390 Giessen, Germany.

#### Purpose (§ 1)

The aim of the agreement is to promote international student and closer cooperation in research and teaching as well as the development of joint projects between Justus Liebig University Giessen and Graduate School to Engineering Science School of Engineering Science of Osaka University.

Specific matters pertaining to the implementation of the exchanges between both institutions shall be negotiated and agreed upon between the parties concerned in each specific case and may be stipulated in writing.

## Extension of Validity (§ 7 b)

The two universities, Justus Liebig University Giessen (Germany) and Osaka University (Japan), declare to extend the duration of the above-mentioned Exchange Agreement for five years, from 31 January 2024 until 30 January 2029.

The two universities also agree to add the following articles to the Exchange Agreement.

### Paragraph 8

### **Governing Law**

The applicable law of this agreement shall be the laws of Germany when the cooperation is carried out at Justus Liebig University Giessen, and by the laws of Japan when carried out at Osaka University.

# Paragraph 9

#### **Security Export Control**

The two universities agree to adhere to and comply with applicable export control laws and regulations. The two universities agree that this academic exchange does not aim for design or development of military equipment, including but not limited to weapons of mass destruction. Weapons of mass destruction are defined as nuclear, chemical, biological weapons and missiles, and other unmanned aerial vehicles for military use.

All other terms and conditions remain unchanged.
