Then go to the third tab (**Consent form**) and confirm your consent.

Once your account has been created, you will be notified via email at the address provided. In the message you will find a link that you can use to log in to CRIS with your JLU user ID (g-ID or s-ID) and your network password.

Please note that using the current research information system during the test operation phase at JLU is voluntary. The data collected during the test phase and validated by the university library will remain stored in the system even after the end of the test phase so that it can be made available to the live system as an initial data import.
