Submission of Thesis

(1) The thesis focus must be on a field which is represented in research and teaching in both Faculties of Science according to § 1 para. 1. A thesis in the Faculties named in § 1 paras. 2 and 3 must be scientific in content and focus on a field which is represented in research and teaching in these two Faculties (§ 1 para. 2 and 3). In addition, the thesis must fulfil the following criteria: It must

1. promote scientific knowledge by means of independent research;
2. comply with the relevant methodological principles of the pertinent field;
3. contain documentation of the evaluated material and the literature used, documentation to be in line with scientific working principles and
4. present the subject in a complete, clear and formally correct manner in accordance with the rules and requirements of the language in which it is written (see para. 5).

(5) The thesis shall be submitted either in the German or English language. In well-justified exceptional cases the Joint PhD Board may permit a different language. The language specified in the PhD admission application may only be changed subsequently with the approval of the Joint PhD Board.
