

## **Workshop 2 - DAAD-Studierendenvertreter\*innen: Zusammenarbeit zwischen Studierendenschaften und den Akademischen Auslandsämtern/ International Offices**

Beschreibung:

Die Zusammenarbeit zwischen International Office/Akademischem Auslandsamt und Studierendenschaften sind häufig scheinbar von beidseitigem gutem Willen geprägt. Die Arbeit für die Zielgruppe einigt. Dennoch gibt es Probleme in der Praxis, die zunächst unverständlich erscheinen, die Studierendenschaft stellt sich in entscheidenden Punkten gegen Vorhaben oder „zieht nicht mit“, International Offices unterstützen in Einzelfällen oder auch bei strukturellen Vorhaben Studierende/die Studierendenschaft nicht, wie sie es könnten/es erwartet wird: Woran liegt das? Im Workshop werden die unterschiedlichen Voraussetzungen und Interessen sichtbar gemacht, die für Studierendenschaft und International Offices prägend sind, und Gemeinsamkeiten wie auch Differenzen, die in der täglichen Arbeit wenig sichtbar sind, erarbeitet.

**Eleni Andrianopulu** (F), Diploma in Translation and Linguistics, is the Acting Director of the International Office of Bielefeld University (UNIBI). She has been active as a student representative in several board president and member positions in Germany and Europe (2001-2012) and has worked in the Executive Board and the Board of Trustees of the German Academic Exchange Service (DAAD) (2006-2012). She is currently active as an assessor for the Human Resources Strategy for Researchers of the European Commission and as an Advisory Board member of the EURAXESS TOP IV Project under Horizon2020 SwafS 24-2017. Further, she is responsible for the monitoring of all 14 projects in the internationalisation and diversity strategy (2016-2019) of UNIBI and has since 2015 a leading role in the development of these strategies, the development and the acquisition of third party funding in projects for refugees and international researchers at UNIBI, like Horizon2020 (BRIDGE and BRIDGE II – Project Coordinator), Humboldt-Foundation (PSI 2nd, 3rd and 4th round – Project coordinator), Mercator Foundation (Refugees), DAAD (STIBET-Doktoranden). She has worked as an assessor in Germany for the DAAD, AQAS, ACQUIN, ZEVA, AHPGS and the Stifterverband. She is an active member in the EURAXESS and SAR Germany Network and has given several presentations in this context about researchers in danger, international PhD-students, international research support and university relocation services, integration of international students, such as at DAAD Conferences, EURAXESS Workshops, at ESOF, inHERE, ACA Seminar on migration. She is a member of several university and municipality working groups in Bielefeld and Athens on migration and integration issues.
