Terms and Conditions

- **Costs**

The program fee of € 2,400,-- includes an academic seminar, a language course, two field trips (to a research institution and a pharmaceutical company), the cultural program (incl. Berlin Field Trip and Brussels Field Trip), accommodation in shared bed rooms (hotel, one bathroom) incl. breakfast from July 18 until August 15, health, liability and accident insurance, ticket for public transportation in Giessen and study material.

If your application is accepted and we receive your participation fee payment before or on April 15, 2020, an early bird discount will be granted and the participation fee will be reduced to € 2,200.

Please note: There is no reduction for participants who do not take part in the whole program.

Participants who join the optional trip to Rhine Valley (August 08, 2020) will have to pay an additional € 50.

- **Registration and Payment Information**

Upon receipt of an application, the ISU Giessen will review the documents and confirm or reject the application. Upon acceptance, applicants will receive detailed payment information for the program fee to complete the registration. The program fee is due within 30 days from the date of the invoice. Payments are to be made by bank transfer or cheque.

The transfer of a participant's program fee to our bank account will be considered a binding agreement. As a result, a place will be reserved for at the ISU, provided that the maximum number of participants has not been reached by the time the payment is received. Please understand that no place can be reserved for a participant until we have received the payment.

As soon as we have received the program fee, we will send you a confirmation receipt for the actual amount we have received, as well as a reservation confirmation. If, however, the maximum number of participants has been reached, you will be refunded the program fee minus the fees charged by the bank for processing the money transfer.

In case a participant does not fulfill the payment obligations, the participant hereby acknowledges and agrees that his/ her registration will automatically be rejected.

If you require a visa to take part in ISU, please note that full payment must be made before we can issue the letter of invitation for visa application purposes. Banks usually also charge us for processing transfers. Please note that we will have to pass these fees on to you.

- **Cancellation**

If, for any reason, a participant wants to withdraw his/ her registration, the participant has to inform the ISU Giessen immediately. The fee which has already been paid will be refunded under the following conditions:
